Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Street Cars Manchester via the Website. This definition incorporates where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and/or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulations and secondary legislation, for as long as the GDPR is effective in the UK;
GDPR	the General Data Protection Regulation (EU) 2016/679;
Street Cars Manchester, or us	Street Cars Manchester, a company incorporated in England and Wales with registered number 04939390 whose registered office is at 29-31 Sackville Street, Manchester, M1 3LZ;
UK and EU Cookie Law	the Privacy and Electronic Communications (EC Directive) Regulations 2003 as amended by the Privacy and Electronic Communications (EC Directive) (Amendment) Regulations 2011;
User or you	any third party that accesses the Website and is not either (i) employed by Street Cars Manchester and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Street Cars Manchester and accessing the Website in connection with the provision of such services; and
Website	the website that you are currently using, www.streetcarsmanchester.co.uk, and any sub-domains of this site unless expressly excluded by their own terms and conditions.

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Street Cars Manchester and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Street Cars Manchester is the "data controller". This means that Street Cars Manchester determines the purposes for which, and the manner in which, your Data is processed.

Data collected

- 5. We may collect the following Data, which includes personal Data, from you:
 - a. name;
 - b. contact Information such as email addresses and telephone numbers;
 - c. IP address (automatically collected);
 - d. in each case, in accordance with this privacy policy.

How we collect Data

- 6. We collect Data in the following ways:
 - a. data is given to us by you; and
 - b. data is collected automatically.

Data that is given to us by you

- 7. Street Cars Manchester will collect your Data in a number of ways, for example:
 - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
 - b. when you register with us and set up an account to receive our products/services;
 - c. when you enter a competition or promotion through a social media channel;
 - d. when you make payments to us, through this Website or otherwise;

in each case, in accordance with this privacy policy.

Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
 - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

Who we share Data with

 - a. our employees, agents and/or professional advisors in order to provide a comprehensive service;

in each case, in accordance with this privacy policy.

Keeping Data secure

- 13. To provide the highest quality of service and ensure efficient handling of bookings, ("we," "our," or "us") may occasionally subcontract rides to affiliated or partner companies. This enables us to meet customer demand and fulfil bookings promptly.
 - a. In such instances, limited personal data necessary to complete your booking (such as your name, pick-up and drop-off locations, and contact information) may be shared with these affiliated companies. We only share information strictly required to complete the job and ensure passenger safety and satisfaction.
 - b. We confirm that our partnered companies comply with GDPR and handle your personal data with the same level of security and confidentiality as we do. You can be assured that any data shared for these purposes will not be used for any other reason beyond fulfilling your booking.
 - c. If you would prefer that we do not share your data with affiliated companies, please let us know at the time of booking, and we will do our best to accommodate your request.

Your rights
